The Project proposes development of a multi-family residential neighborhood that includes 38 residential units in a mix of 2 triplexes and 16 duplexes (total 84,946 square feet), 76 enclosed parking spaces and 18 exterior guest spaces, 5,700 square feet of open space, and 23,460 square feet of snow storage, as well as the realignment of the multi-use path along the north, east, and south sides of the Project Site. Finally, the Project includes two storm drain systems: one to collect
