Allow value-added agricultural improvements to an existing fruit packing and cold storage facility. Improvements include a 6,120 square-foot canopy, a 14,358 square-foot canopy and a 21,521 square-foot canopy for existing cold storage buildings; a 58,788 square-foot expansion of an existing cold storage facility and an added 17,512 square-foot canopy; and a new 12,800 square-foot farm shop building on an approximately 28.0-acre parcel. The subject property is located within the AE-20 (Exclusive Agricultural, 20-acre minimum parcel size) Zone District.
