The project consists of the construction and operation of a hexavalent chromium treatment system at the existing Well 14 site. Due to structural deficiencies, Well 14 would be abandoned and replaced with a new well (Well 23) at the existing Well 14 site. At the Well 14 site, a sewer lateral would be installed connecting to an existing sewer mains underneath Orange Drive. The project provides treatment of water that would be affected by future hexavalent chromium (Cr VI) maximum contaminant levels, which would provide an adequate and regulatory compliant water supply to the City of Vacaville.

Subject: Wells 14 and 23 Hexavalent Chromium Well Treatment Project - CEQA Categorical Exemption

Dear Ms. Dorado,

This memorandum provides an analysis to support the determination by the City of Vacaville (the lead agency) that the proposed Hexavalent Chromium Well Treatment Project, consisting of Wells 14 and 23, is exempt from the California Environmental Quality Act (CEQA) pursuant to Section 15303 of Title 14 of the California Code of Regulations.

Project Description

The project consists of the construction and operation of hexavalent chromium treatment systems at the existing Well 14 site. Due to structural deficiencies, Well 14 would be abandoned and replaced with a new well (Well 23) at the existing Well 14 site. At the Well 14 site, a sewer lateral would be installed connecting to an existing sewer main underneath Orange Drive. Construction at the well site would result in under 5,000 feet of impervious surfaces. The well site has been subject to previous disturbances from past grading, well drilling, and paving activities. No tree removal would be required.

Exemption Analysis

Suitability of Use of Categorical Exemption

The project qualifies for a Categorical Exemption (CE) under CEQA. Public Resources Code Section 21084 requires the CEQA Guidelines to identify classes of projects that have been determined not to have a significant effect on the environment and are therefore exempt from CEQA (see Article 19, Sections 15301 through 15333 of the CEQA Guidelines). These classes of projects under CEQA fall into several distinct categories; Class 3 applies to the project.

Section 15303 – New Construction or Conversion of Small Structures

Class 3 projects consist of construction and installation of a limited number of new, small facilities or structures; installation of small new equipment and facilities in small structures; and the conversion of existing small structures from one use to another, where only minor exterior modifications are required.

The project would include the construction of new, small facilities consisting of the hexavalent chromium treatment system, a new well, and associated pipelines at the existing Well 14 site. Section 15303 applies to structures in urbanized areas with a permanent footprint of 10,000 square feet or less. As the project's new, small facilities fall within this threshold, Class 3 exemption applies.



Discussion of CEQA Guidelines 15300.2 Exceptions

The use of a Categorical Exemption is limited by the exceptions listed in CEQA Guidelines Section 15300.2, which indicate that projects determined to be categorically exempt from CEQA cannot:

1. Impact an environmental resource of hazardous or critical concern where designated, precisely mapped, and officially adopted pursuant to law by federal, state, or local agencies if a Class 3, 4, 5, 6, or 11 Categorical Exemption is used;
2. Result in a significant cumulative impact;
3. Result in a significant effect on the environment due to unusual circumstances;
4. Result in damage to scenic resources within a designated state scenic highway;
5. Be located on a hazardous waste site included on any list compiled pursuant to Section 65962.5 of the California Government Code; or
6. Cause a substantial adverse change in the significance of a historical resource.

As noted above, the well site is located within a previously disturbed area. The well site does not contain critical habitat for wildlife as this site is previously disturbed and within an urbanized area in Vacaville. Based on a review of the California State Water Resources Control Board's online GeoTracker database¹ and the California Department of Toxic Substances Control's online EnviroStor database², the well site is not located on a hazardous waste site. Accordingly, the project would not impact a designated, precisely mapped, and officially adopted environmental resource of hazardous or critical concern (Exception #1) or result in environmental impacts concerning hazardous waste sites (Exception #5).

Based on the minimal activities associated with the proposed project and the fact that development would occur within a previously disturbed area, it is unlikely the proposed project would result in significant cumulative impacts (Exception #2) or result in a significant effect on the environment due to unusual circumstances (Exception #3).

Based on a review of the California Department of Transportation's Statewide Scenic Highway Viewer³, the nearest officially designated state scenic highway to the well site is State Route 160, located approximately 24 miles east of the well site. Therefore, the project would not damage scenic resources within a designated state scenic highway (Exception #4). Well 14 was constructed in 1993 which does not meet the California Office of Historic Preservation's 45-year age threshold for consideration as a historical resource pursuant to CEQA. Therefore, the project would not cause a substantial adverse change in the significance of a historical resource (Exception #6).
