Project Title: Amendment No. 1 to Revenue License Agreement No. 07-148 with City of San Bernardino Municipal Water District
Project Location: The Project is located within a portion of Twin Creek Channel, situated south of Orange Show Road and east of Chandler Place, and within Assessor Parcel Number 0141-421-11.
Project Description: The San Bernardino County Flood Control District is proposing Amendment No. 1 to Revenue License Agreement No. 07-148 with City of San Bernardino Municipal Water District for the continued non-exclusive access to approximately 26,250 Square Feet of Flood Control District right-of-way in the city of San Bernardino. The license allows for the installation, operation and maintenance of an underground 78-inch water pipeline parallel to District right-of-way. The amendment would extend the existing license term for an additional ten (10) years from March 1, 2026, through February 29, 2036.
