Project Description: The Department of Cannabis Control, pursuant to authority granted under Business and Profession Code, Section 26012, approved a commercial cannabis retail license submitted on 12/24/2025 by California Plant Medicine Alliance, LLC.

Project Activities: The Project includes a regulatory permit to allow for a commercial cannabis manufacturing and distribution facility. This will occur within an existing facility located at 2215 East 16th Street Los Angeles, CA 90021 (APN 5167-012-023). Business will occur on a 0.11-acre lot zoned Industrial in Los Angeles.
