Project Description: The Department of Cannabis Control, pursuant to authority granted under Business and Profession Code, Section 26012, approved a commercial cannabis microbusiness license submitted on 2/12/2026 by R & P 2026 LLC.

Project Activities: The project consists of a Conditional Use Permit to operate a cannabis cultivation facility within an existing 19,000-sq. ft. warehouse located at 1728 KATHLEEN AVE, SACRAMENTO, CA 95815 (APN 265-0401-007-0000). Permitted activities include cultivation, distribution, and retail and will occur on a 1.1-acre parcel in the Light Industrial (M-1) zone.
