II. PROJECT DESCRIPTION

The work to be done consists, in general, of furnishing and installing Rectangular Rapid Flashing Beacon (RRFB) systems, including pole foundations, solar systems, flashing beacons, minor sidewalk removal and replacement, pavement delineation and striping, furnishing and installing signage, and minor pavement rehabilitation.
2. **Surrounding land uses and environmental setting: Briefly describe the project's surroundings:**
Intersection of 10th and Union: north east and southeast corners of intersection are residential, northwest and southwest corners of intersection are commercial. An existing crosswalk crosses 10th Avenue on the southside of the intersection.

Intersection of 18th and Kern: intersection is a 3-leg intersection. Northeast corner of intersection is home to Lincoln Elementary School with residential to the north. West side of 18th Avenue at Kern is home to Grace Valley Church. South east corner of 18th & Kern is industrial. There is an existing crosswalk that crosses 18th Avenue on the north side of the intersection.

Intersection of Rafer Johnson and Sierra: this intersection is a 3-leg intersection. Rafer Johnson (north-south) is controlled by a stop sign, but no traffic control exists on Sierra Street (east-west). The north side

of Sierra Street at Rafer Johnson is commercial with a few restaurants and coffee shops. The south west corner is residential and the southeast corner is home to Dollar Tree. An existing crosswalk crosses Sierra Street on the east side of the intersection.

3. Discretionary approval authority and other public agencies whose approval is required (e.g., permits, financing approval, or participation agreement.)

A City of Kingsburg encroachment permit will be required (construction equipment access and traffic control).
