Ordinance No. 1361 repeals and re-enacts Chapter 17.105 of the Folsom Municipal Code pertaining to Accessory Dwelling Units to provide updates consistent with new State legislation, to standardize and clarify design and development requirements for Accessory Dwelling Units, and to streamline the review process and ensure quality design.
