The City of Victorville respectfully requests an update to the California State Clearinghouse (SCH) posting for the Notice of Intent (NOI) associated with the project identified by SCH No. 2026041394, titled PLAN25-00007 Vesting Tentative Tract Map No. 20547.

The City is requesting that SCH revise the public review period to reflect new dates of **May 8, 2026 through June 8, 2026.**

This request is necessary due to a noticing error that occurred during the initial publication process. While the notice for the Planning Commission public hearing was transmitted to the newspaper for publication in time for a May 1, 2026 through June 1, 2026 review period, the Notice of Intent for CEQA review was inadvertently omitted from that submission. To ensure full and proper public notification in compliance with CEQA requirements, the City has resubmitted the corrected notice to the newspaper. The updated notice will be published on May 8, 2026, and will reflect the revised 30-day public review period.

Attached is the updated Notice of Intent showing the corrected public review dates. The City respectfully requests that SCH update the project posting accordingly.

Notice is hereby given that the public agency named below has completed an Initial Study of the following described project at the following location: Between Mesa View Drive and Pena Road, approx. 1,700 ft north of La Mesa Road.

Project Description:	The Project proposes a vesting tentative tract map to subdivide approximately 15.13 gross acres into 53 residential lots for single-family detached residential development. The proposed minimum lot sizes are 7,200 square feet with a net density of 3.7 dwelling units per acre. The average lot size would be 8,368 square feet.	
Project Location:	The Project site consists of 15.83 acres located between Mesa View Drive and Pena Road, approximately 1,700 feet north of La Mesa Road in the city of Victorville, California, and identified by Assessor Parcel Numbers 3096-361-05, 06, 07.	
This Initial Study was completed in accordance with the Lead Agency's Guidelines for Implementing the California Environmental Quality Act (CEQA). This Initial Study was undertaken for the purpose of deciding whether the project may have a significant effect on the environment. On the basis of such Initial Study, the Lead Agency's Staff has concluded that the project will not have a significant effect on the environment, and has therefore prepared a Draft Mitigated Negative Declaration. The Initial Study reflects the independent judgment of the Lead Agency.
