The Project involves the development and operation of a state-of-the-art, multidisciplinary research and innovation hub, referred to as UCLA Research Park, located on the site occupied by Westside Pavilion shopping center, approximately two miles from the UCLA main campus in the City of Los Angeles. The Project entails adaptive reuse of approximately 744,400 GSF of existing occupiable floor area within the Research Park East and West buildings via interior improvements plus limited new construction to provide over 800,000 GSF of scientific program space and associated amenities, with approximately 29,000 SF of open space and outdoor amenity areas and approximately 1,100 existing parking spaces on-site, for a total of up to approximately 1.35 million GSF of research park uses.
