The California Department of Transportation (Caltrans) initiated a District Director's Order to make drainage repairs on State Route 16 at post mile (PM) 8.37 and PM 24.29 in Yolo County. Caltrans proposes to remove failed culverts and replace with new concrete arch culverts, install headwalls, roadway excavation, place and compact aggregate base (AB), concrete backfill, hot mix asphalt (HMA) paving, traffic control, and incidental work.
