American Dark Fiber, LLC, in coordination with California Department of Technology, proposes to construct fiber optic lines for the Middle Mile Broadband Network project. The work includes thirteen sections totaling approximately 21,095 feet of underground conduit along State Route (SR) 116 and SR 1 in Sonoma County, extending between Rohnert Park and Jenner. Construction will involve trenching and conduit placement to improve broadband connectivity and network reliability in the area for the underserved community.
