Project Location: The Project is located at 7700 EDGEWATER DR. #630 OAKLAND, CA 94621.

County: ALAMEDA

Project Description: The Department of Cannabis Control, pursuant to authority granted under Business and Professions Code, Section 26012, approved a Microbusiness commercial cannabis license submitted on 3/21/2025, by KENABISA L.L.C.

Project Activities: The Project will consist of microbusiness that will engage in 375 sqft of cannabis delivery, 350 sqft of distribution, and 120 sqft of nonvolatile manufacturing in existing 227,000 sq ft facility. The project will receive water from East Bay Municipal Utility District and energy is serviced by PG&E. The project is an existing facility that was previously used by a different commercial cannabis business.
