Caltrans approves of the encroachment permit for Southern California Edison to replace a deteriorated pole (#1405919E) within Caltrans right-of-way (ROW) along State Route (SR) 150 at post mile (PM) 11.13, as well as perform traffic control activities, in the City of Ojai, Ventura County. Excavation will have a depth of 6 feet, and average width and length of 2 feet by 2 feet. No public utilities will be relocated, and no new ROW will be acquired.

- If there is an active nest on the pole, the applicant will follow standard procedures to avoid impacts to the nest until the young have fledged. This will be done under the guidance of a professional biologist.
- Applicant must conduct necessary bird surveys of pole and trees/veg adjacent up to 500 feet from pole for potential nests. If an active nest is found, all appropriate bird protection BMPs should be employed.
