<u>Project Description</u>	
The California Department of Transportation (Caltrans) initiated a District Director's Order project to prevent stormwater runoff and to secure/stabilize the former ice house property located northeast of the Marysville District Office on State Route 20 at post mile (PM) 1.24 in Yuba County. This project is needed to increase safety and security for state employees and to minimize stormwater runoff from the property. Caltrans proposes stormwater remediation, demolish and clear damaged concrete masonry units (CMUs), remove obsolete electrical equipment, roadway excavation, place aggregate base (AB), and incidental work.


