The California Department of Transportation (Caltrans) initiated a District Director's Order to replace failed corrugated metal pipe (CMP) culverts on State Route 162 at post mile (PM) 2.67 in Butte County. Caltrans proposes soil excavation, replace failed CMP culverts and replace with reinforced concrete pipe (RCP) culverts, replace existing rock slope protection (RSP) at outlet, backfill, traffic control, and incidental work.
