Description of Nature, Purpose and Beneficiaries of Project:

DWR staff will perform mowing and grading along the left side and right side of Reach 2 of the California Aqueduct from MM 46.20 to 70.90. A motor grader with approx. 15 foot wide blade will be used to maintain the established roads. Mowing will be done using a tractor and pull behind mower attachment for 10 feet on either side of the established roads, with mower blades remaining 6 inches above the ground. All work is within DWR right of way.
