Project Location: The Project is located at 31889 Corydon Suite 170, in Riverside County.

Project Description:

The Department of Cannabis Control, pursuant to authority granted under Business and Profession Code Division 10, Chapter 2, Section 26012, approved a Cannabis License submitted on 02/02/2026, by Fatima Rahman. Fatima Rahman applied for one Cannabis Microbusiness License in an indoor building for the sale, distribution, and manufacturing of cannabis goods.

Project Activities:

The Project consists of non-volatile, solvent-less manufacturing, with accessory use for wholesale and retail distribution and retail dispensary of medicinal and recreational cannabis-derived products within an existing 4,925 square foot building. The project does not involve modifications or demolition. The operation will utilize electricity from the grid and water from a retail water supplier.

Reasons Why Project is Exempt:

The Department of Cannabis Control has determined that the project is a Class 32 Categorical Exemption project. Class 32 consists of projects characterized as in-fill development meeting the conditions described in this section.(a) The project is consistent with the applicable general plan designation and all applicable general plan policies as well as with applicable zoning designation and regulations.(b) The proposed development occurs within city limits on a project site of no more than five acres substantially surrounded by urban uses.(c) The project site has no value, as habitat for endangered, rare or threatened species.(d) Approval of the project would not result in any significant effects relating to traffic, noise, air quality, or water quality.(e) The site can be adequately served by all required utilities and public services. The project site does not propose any expansion and none of the exceptions to the exemption defined in Section 15300.2 apply to the Project.
