Project Location: The Project is located at 2373 Westwood BLVD, Los Angeles, CA 90064 (APN 4322-003-030).

County: Los Angeles

Project Description: The Department of Cannabis Control, pursuant to authority granted under Business and Profession Code, Section 26012, approved a commercial cannabis retailer license submitted on 4/21/2026 by Rayan Rameh.

Project Activities: The project consists of commercial cannabis retailer located on an existing Non-Storefront Retail (Type 9) Annual License Application to an Annual License to be located on an existing site zoned for Neighborhood Commercial, C4-1VL-POD at 2373 W Westwood Boulevard, Los Angeles CA 90064 (Assessor's Parcel Number 4322-003-030). The Project-Specific Information (LIC-4013-FORM) submitted by the Applicant states that existing structures will remain with no expansion proposed (Exhibit A). Existing City sewer service is provided to the project site, and water and electricity are provided by the City of Los Angeles Department of Water and Power. Operations would be seven days per week from 8:00 a.m. to 11:30 p.m.
