A request by Jefferey Smith for a Major Grading Permit (GRAD2025-00177) to authorize the grading for the construction of a 1,399-square-foot single-family residence with an 504-square-foot attached garage, septic system and associated site improvements. The proposed project will disturb approximately 25,000 square-feet (0.57 acres) of the 2.02-acre parcel, including 580-cubic-yards of cut and fill. The proposed parcel is within the Agricultural land use category and is located at approximately 50 feet west of the corner of Play Doe Lane and Maverick Way (APN: 015-231-007), approximately 6.5 miles east of the city of Paso Robles. The project site is in the El Pomar-Estrella Sub-area of the North County Planning Area.
