Project Description

Caltrans approves of the encroachment permit for Southern California Edison to replace a deteriorated wooden pole with a lightweight steel pole within Caltrans right-of-way (ROW) along State Route (SR) 118 at post mile (PM) 15.36, as well as perform traffic control activities, in the City of Moorpark, Ventura County. Excavation will have a maximum depth of 10 feet and minimum depth of 5 feet, and an average width and length of 5 feet by 5 feet. No public utilities will be relocated, and no new ROW will be acquired.
