The proposed project is the development of a heavy industrial distribution facility, encompassing approximately 27.49 acres on a 58.25 acre property. The proposed project features a building footprint of approximately 151,760 square feet, with associated site improvements including parking, truck access, and landscaping. The project will involve the construction of a concrete building designated for distribution purposes within a heavy industrial zone. The site plan includes full access points for cars, vans, and trucks, ensuring efficient circulation and transportation management. The proposed building will be surrounded by parking facilities, providing 183 standard parking stalls, 7 accessible stalls, and dedicated parking for vans and trucks. The remaining 30.76 acres will be left undeveloped.
