Project Description: The proposed cultivation project described herein (Project) includes the cultivation of up to 10,000 square feet (SF) of mixed-light mature canopy located in Trinity County on Assessor's Parcel Number (APN): 015-180-045-000. The applicant is seeking a Small Mixed-Light Cannabis Cultivation License from the County (CCL-651) and is also seeking an Adult-Use Small Mixed-Light Tier 1 Cannabis Cultivation License from the Department of Cannabis Control (DCC; CCL22-0001029, Expires on 2025-02-09). Cultivation activities will include approximately 10,000sqft of cannabis mature canopy in seven (7) 24'x84' greenhouses. Water for the project is provided by an onsite, permitted groundwater well and stored in four (4) 5,000-gallon water storage tanks, three (3) 2,500-gallon tanks and a 1,500-gallon tank are used for nutrient mixing. Existing infrastructure includes six (6) 24'x84' greenhouses for a total of approximately 8,640sqft existing mature canopy; 10,000sqft immature canopy in a 200'x50' open staging area with pots of various sizes, a 10'x10' compost area, a 10'x10' shed for ag chemical storage and a 30'x72' (2,160sqft) processing, drying, harvest storage shop. There is a permitted septic system onsite to serve the project's wastewater needs as well as temporary portable toilets. Power for the project is provided by TPUD. Proposed activities include the installation of an additional 1,360sqft mature canopy area directly adjacent of the existing greenhouses on previously disturbed ground. The project will install 6' hoop rows of various lengths, pots and bags of various sizes, which will then transition to a 24'x84' permanent greenhouse with 1,360sqft of mature canopy.
