Project Description: The proposed cultivation project described herein (Project) includes the cultivation of up to 10,000 square feet (SF) of outdoor mature canopy located in Trinity County on Assessor's Parcel Number (APN): 020-520-001-000. The applicant is seeking a Small Mixed-light Cannabis Cultivation License from the County (CCL-756) and is also seeking an Adult-Use Small Mixed-light Cannabis Cultivation License from the Department of Cannabis Control (DCC; CCL20-0001169, Expires on 2024-09-10). Cultivation activities will include approx. 10,000sqft of mature canopy in ten (10) 10'x100' greenhouses. Existing support infrastructure includes five (5) 20'x100' greenhouses for immature canopy, 1-million-gallon rainwater pond, a 20'x20' generator and fuel storage shed, two (2) 5,000-gallon and two (2) 2,500-gallon water tanks, a 15'x15' compost area, and a 32'x72' barn for immature canopy, ag chemical storage. There is a permitted septic system on the adjacent parcel, APN 020-500-004 that services the project's wastewater needs, owned by the applicant. Power for the project is provided by generators less than 50hp. Proposed activities include construction of a 30'x60' harvest storage and processing building. Certified by the Board of Supervisors on December 21, 2020 (Resolution 2020-103). Pursuant to CEQA Guidelines (California Code of Regulations, Title 14) Section 15168, the impacts associated with the proposed project were studied, and mitigation measures concerning such impacts were developed, in the Cannabis Program EIR.
