Project Description: The proposed cultivation project described herein (Project) includes the cultivation of up to 10,000 square feet (SF) of outdoor canopy located in Trinity County on Assessor's Parcel Number (APN): 024-300-005-00. The applicant is seeking a Small Outdoor Cannabis Cultivation License from the County (CCL-797) and currently holds an Adult-Use Small Outdoor Cannabis Cultivation License from the Department of Cannabis Control (DCC; CCL23-0000494, Expires on 2025-01-26). Cultivation activities will include development of less than 20,000sqft graded terraces for installation of approx. 8,730sqft mature canopy in thirty-eight (38) hoop houses for mature canopy of the following dimensions: one (1) 6'x8', one (1) 6'x12', one (1) 6'x15', two (2) 6'x20', one (1) 6'x22', one (1) 6'x24', one (1) 6'x28', one (1) 6'x32', one (1) 6'x33', two (2) 6'x36, two (2) 6'x37', two (2) 6'x38', three (3) 6'x40', seven (7) 6'x42', one (1) 6'x44', three (3) 6'x45', two (2) 6'x48', two (2) 6'x50', one (1) 6'x52', one (1) 6'x58', one (1) 6'x55', one (1) 6'x65'; and two (2) 6'x30' hoop houses for immature canopy. Other supporting structure will include: a 20'x20' cannabis waste and composting area; a 4'x6' pump house; a 550-gallon nutrient mixing tank and three (3) 2,500-gallon water storage tank. Proposed development will include the development of six (6) 10'x12' sheds for petroleum storage, agricultural chemical and pesticide storage, packaging and post-harvest processing that will become harvest storage. All proposed development activities will be performed in previously disturbed areas; no tree or bursh removal is proposed. Power for this project will be provided by Trinity PUD, water will be supplied by a permitted onsite groundwater well, and a permitted

onsite septic will serve the Project's wastewater needs. A more detailed project description can be found in the Appendix C Checklist.

The County finds that the adoption of the proposed project falls within the Trinity County Cannabis Program Environmental Impact Report ("EIR")(SCH# 2018122049). Certified by the Board of Supervisors on December 21, 2020 (Resolution 2020-103). Pursuant to CEQA Guidelines (California Code of Regulations, Title 14) Section 15168, the impacts associated with the proposed project were studied, and mitigation measures concerning such impacts were developed, in the Cannabis Program EIR.
