Project Description: The proposed cultivation project described herein (Project) includes the cultivation of up to 10,000 square feet (SF) of outdoor mature canopy located in Trinity County on Assessor's Parcel Number (APN): 015-420-002-000. The applicant is seeking a Small Outdoor Cannabis Cultivation License from the County (CCL-314) and currently holds an Adult-Use Small Outdoor Cannabis Cultivation License from the Department of Cannabis Control (DCC; CCL19-0002380, Expires on 2024-12-30). Cultivation activities will include approximately 9,952sqft of mature canopy in (198) 8' circular beds with approximately 50.26sqft canopy each bed. Existing support infrastructure includes a total of approximately 8,820sqft mature canopy in (180) 7'x7' areas, as well as 10'x40' immature canopy area, 25'x50' shop for processing, immature canopy and harvest storage; a 30'x30' compost area, a permitted onsite groundwater well, an 8'x8' ag chemical storage shed, a 275-gallon nutrient mixing tank, a 3,000-gallon and two (2) 2,500-gallon water storage tanks. There is a permitted septic system onsite that services the project's wastewater needs. Power for the project is provided by solar array. Proposed activities include the installation of additional mature canopy as detailed above and expansion of the existing immature canopy area to be 20'x40', both on previously disturbed area with hand tools only. A more detailed project description can be found in the Appendix C Checklist.

Certified by the Board of Supervisors on December 21, 2020 (Resolution 2020-103). Pursuant to CEQA Guidelines (California Code of Regulations, Title 14) Section 15168, the impacts associated with the proposed project were studied, and mitigation measures concerning such impacts were developed, in the Cannabis Program EIR.
