Project Description: The proposed cultivation project described herein (Project) includes the cultivation of up to 10,000 square feet (SF) of outdoor mature canopy located in Trinity County on Assessor's Parcel Number (APN): 015-440-052-000. The applicant is seeking a Small Outdoor Cannabis Cultivation License from the County (CCL-834) and is also seeking an Adult-Use Small Outdoor Cannabis Cultivation License from the Department of Cannabis Control (DCC). Cultivation activities will include approx. 9,996sqft mature canopy in (204) 5'x5' boxes with 49sqft canopy each. Existing support infrastructure includes a 6'x40' hoop house for immature canopy, a 24'x28' garage for immature canopy, processing, and harvest storage; a 10'x12' shed for petroleum storage, a 16'x6'7" shed for ag chemical storage, a permitted onsite groundwater well, five (5) 2,500-gallon water storage tanks and a 1,000-gallon nutrient mixing tank. Proposed activities include the installation of an additional 6'x40' hoop house for immature canopy, a 15'x20' compost area, two (2) 5,000-gallon water storage tanks and the installation of (204) 5'x5' boxes for mature canopy as described above, on previously disturbed area. There is a permitted onsite septic system that services the project's wastewater needs. Power for the project is provided by TPUD. A more detailed project description can be found in the Appendix C Checklist.

Certified by the Board of Supervisors on December 21, 2020 (Resolution 2020-103). Pursuant to CEQA Guidelines (California Code of Regulations, Title 14) Section 15168, the impacts associated with the proposed project were studied, and mitigation measures concerning such impacts were developed, in the Cannabis Program EIR.
