Project Description: The proposed cultivation project described herein (Project) includes the cultivation of up to 10,000 square feet (SF) of outdoor mature canopy located in Trinity County on Assessor's Parcel Number (APN): 014-440-049-000. The applicant currently holds a Small Outdoor Cannabis Cultivation License from the County (CCL-400) and currently holds an Adult-Use Small Outdoor Cannabis Cultivation License from the Department of Cannabis Control (DCC; CCL19-0002396, Expires on 2025-01-09). Cultivation activities are approved to include approx. 9,120 SF of outdoor mature canopy area that includes sixteen (16) 6'x95' hoop house rows. Existing support infrastructure includes a 30'x36' hoop house for immature canopy, a 6'x12' compost area, a permitted onsite groundwater well, five (5) 2,500-gallon and one (1) 1,100-gallon water storage tanks, two (2) 275-gallon and a 100-gallon mixing tanks; processing will occur within a 12'x16' building, harvest storage will be in a 12.5'x24' building, agricultural and chemical storage will occur in an 8'x12' shed. Power for the project is provided by TPUD grid. There is a permitted onsite septic system that services the project's wastewater needs. A more detailed project description can be found in the Appendix C Checklist.
