Project Description: The proposed cultivation project described herein (Project) includes the cultivation of up to 10,000 square feet (SF) of mature mixed-light cannabis located in Trinity County on Assessor's Parcel Number (APN) 015-420-040-000. The applicant currently holds a Small Mixed-Light Cannabis Cultivation License from the County (CCL-136) and also currently holds an Adult-Use Small Mixed-Light Tier 1 Cannabis Cultivation License from the Department of Cannabis Control (DCC; CCL18-0001350; Expires on 2025-05-10). Cultivation activities include approx. 9,404-SF of mature mixed-light cannabis grown in two (2) primitive 6'x50' hoop houses and three (3) greenhouses of various dimensions (30'x82', 30'x114' and 30'x132') sized such that the mature canopy would remain under 10,000-SF. Existing cultivation support infrastructure includes a permitted onsite groundwater well, three (3) 10'x12' storage sheds used for administrative hold, pesticide, agricultural chemical, harvest storage as well as a 10'x20' carport for general storage, a 30'x30' compost area, three (3) 550-gallon nutrient mixing tanks, four (4) 4,900-gallon, one (1) 500-gallon and five (5) 2,500-gallon water storage tanks. Proposed activities include the installation of two (2) 8'x40' (320-SF) shipping containers for harvest storage, immature plant area, and processing, on previously disturbed area with minimal leveling using a small bobcat. One of the 6'x50' hoop rows will also be used for immature canopy before transitioning to mature canopy. Power for the project is provided to the site via an existing connection to Trinity Public Utilities District. There is a permitted septic system onsite to serve the project's wastewater needs. The County finds that the adoption of the proposed project falls within the Trinity County Cannabis Program Environmental Impact Report ("EIR")(SCH# 2018122049). Certified by the Board of Supervisors on December 21, 2020 (Resolution 2020-103). Pursuant to CEQA Guidelines (California Code of Regulations, Title 14) Section 15168, the impacts associated with the proposed project were studied, and mitigation measures concerning such impacts were developed, in the Cannabis Program EIR.
