Project Description: The proposed cultivation project described herein (Project) includes the cultivation of up to 10,000 square feet (SF) of outdoor mature canopy with proposed transition to mixed-light mature canopy located in Trinity County on Assessor's Parcel Number (APN): 020-340-035-000. The applicant currently holds a Small Outdoor Cannabis Cultivation License from the County (CCL-604), is seeking a Small Mixed-Light License type from the County and also currently holds an Adult-Use Small Mixed-Light Tier 1 Cannabis Cultivation License from the Department of Cannabis Control (DCC; CCL20-0000272, Expires on 2025-05-01). Cultivation activities are approved to include approx. 8,960sqft mature canopy in two (2) 26'x80', two (2) 20'x80' hoop-houses and an additional 20'x80' hoop house proposed for installation on previously disturbed area. Existing support infrastructure includes a 12'x40' hoop-house for immature canopy, an 8'x24' metal storage container for agricultural chemical and pesticide storage, three (3) 10'x12' sheds for general storage and administrative hold, a 10'x20' compost area for cannabis waste, a permitted onsite groundwater well for agricultural and domestic use, four (4) 5,000-gallon, one (1) 2,500-gallon water storage tanks and three (3) 275-gallon nutrient mixing tanks. There is a temporary portable toilet that services the project's wastewater needs until the onsite permitted septic system is ready for use. Power for the project is provided by generators less than 50hp. A more detailed project description can be found in the Appendix C Checklist.

The County finds that the adoption of the proposed project falls within the Trinity County Cannabis Program Environmental Impact Report ("EIR")(SCH# 2018122049). Certified by the Board of Supervisors on December 21, 2020 (Resolution 2020-103). Pursuant to CEQA Guidelines (California Code of Regulations, Title 14) Section 15168, the impacts associated with the proposed project were studied, and mitigation measures concerning such impacts were developed, in the Cannabis Program EIR.
