Project Description: The proposed cultivation project described herein (Project) includes the cultivation of up to 10,000 square feet (SF) of outdoor mature canopy located in Trinity County on Assessor's Parcel Number (APN): 016-170-065-000. The applicant is seeking a Small Outdoor Cannabis Cultivation License from the County (CCL-846) and is also seeking an Adult-Use Small Outdoor Cannabis Cultivation License from the Department of Cannabis Control (DCC). Cultivation activities are approved to include approx. 9,996sqft mature canopy in two-hundred and four (204) proposed 7'x7' raised boxes. Existing support infrastructure is approved to include three (3) 2,500-gallon, one (1) 1,000-gallon and one (1) 1,110-gallon water storage tanks; one (1) 8'x46' semi-trailer for post-harvest processing and harvest storage; one (1) 8'x14.5' trailer for agricultural chemical and pesticide storage. Proposed support infrastructure is approved to include installation of a 1,000-gallon nutrient mixing tank and a 2,500-gallon water storage tank; two (2) 20'x60' uncovered drying areas, a 6'x100' hoop house for immature canopy; and a 20'x20' cannabis waste composting/chip and till area on previously disturbed areas. Power for the project is supplied by TPUD and there is a permitted onsite septic system to serve the project's wastewater needs. A more detailed project description can be found in the Appendix C Checklist.

Certified by the Board of Supervisors on December 21, 2020 (Resolution 2020-103). Pursuant to CEQA Guidelines (California Code of Regulations, Title 14) Section 15168, the impacts associated with the proposed project were studied, and mitigation measures concerning such impacts were developed, in the Cannabis Program EIR.
