Project Description: The proposed cultivation project described herein (Project) includes the cultivation of up to 10,000 square feet (SF) of mature canopy located in Trinity County on Assessor's Parcel Numbers (APNs): 019-520-015-000 & 019-520-014-000. The applicant is seeking a Small Outdoor Cannabis Cultivation License from the County (CCL-855) and is also seeking an Adult Use Small Outdoor Cannabis Cultivation License from the Department of Cannabis Control (DCC). Cultivation activities are approved to include approx. 6,717.5sqft of mature canopy in (34) 5.5'x5.5', (75) 5'x5', (99) 6'x6' and (10) proposed 5'x5' areas. Existing support infrastructure is approved to include a permitted onsite groundwater well, three (3) 3,000-gallon and one (1) 2,500-gallon water storage tanks; a 275-gallon and a 1,000-gallon nutrient mixing tanks; a 14'x40' hoop house for immature canopy; two (2) 10'x10' cannabis waste, composting and chip-till areas; one (1) 4'x8' shed for agricultural chemical and pesticide storage; an 8'x10' shed for petroleum storage. Power for the project is provided by solar and generators less than 50hp. There is a permitted onsite septic system to serve the project's wastewater needs. Proposed activities are approved to include the installation of an 8'x15' shed for post-harvest processing and harvest storage; installation of another 8'x15' shed for harvest storage as well as the ten (10) mature canopy areas described above, all on previously disturbed areas. Road improvement components are approved to include surfacing as needed. A more detailed project description can be found in the Appendix C Checklist.



The County finds that the adoption of the proposed project falls within the Trinity County Cannabis Program Environmental Impact Report ("EIR")(SCH# 2018122049). Certified by the Board of Supervisors on December 21, 2020 (Resolution 2020-103). Pursuant to CEQA Guidelines (California Code of Regulations, Title 14) Section 15168, the impacts associated with the proposed project were studied, and mitigation measures concerning such impacts were developed, in the Cannabis Program EIR. No further environmental review is required because the County finds, based on substantial evidence in the Record of Proceedings, that approval of this project is a "later activity" associated with the Cannabis Program EIR, as defined by subsection (c) of Section 15168, in that (i) all impacts associated with the approval of this project are within the scope of environmental review previously studied, and (ii) the requirements and mitigations required by Chapter 17.43 and 17.43G of the Trinity County Code, adequately serve to mitigate the impacts associated with approval of this project.
