Project Description: The proposed cultivation project described herein (Project) includes the cultivation of up to 10,000 square feet (SF) of mature canopy located in Trinity County on Assessor's Parcel Number (APN): 015-420-037-000. The applicant is seeking a Small Outdoor Cannabis Cultivation License from the County (CCL-857) and is also seeking an Adult Use Small Outdoor Cannabis Cultivation License from the Department of Cannabis Control (DCC). Cultivation activities are approved to include approx. 9,972sqft of mature canopy in (277) 5'x5' boxes with 6'x6' canopy areas each. Existing support infrastructure is approved to include a permitted onsite groundwater well, an 8.5'x12.5' shed for ag chemical storage and a 4'x8' shed for cannabis waste compost. Proposed project activities are approved to include installation of five (5) 2,500-gallon water storage tanks, seven (7) 275-gallon nutrient mixing tanks, a 30'x50' metal building for processing and harvest storage and two (2) 6'x40' hoop houses for immature canopy; proposed activities are not approved to include any tree removal associated with project development. Power for the project is provided by TPUD and a permitted onsite septic system serves the project's wastewater needs. A more detailed project description can be found in the Appendix C Checklist.
