Project Description: The proposed cultivation project described herein (Project) includes the cultivation of up to 10,000 square feet (SF) of mature canopy located in Trinity County on Assessor's Parcel Number (APN): 019-640-022-000. The applicant is seeking a Small Outdoor Cannabis Cultivation License from the County (CCL-768) and is also seeking an Adult-Use Small Outdoor Cannabis Cultivation License from the Department of Cannabis Control (DCC). Cultivation activities are approved to include approx. 7,542sqft mature canopy in (207) 6'x6' canopy areas. Existing support infrastructure is approved to include an 18'x22' processing area and 10'x20' immature canopy area, also including a 2,500-gallon water storage tank, a 1,000-gallon nutrient mixing tank and a permitted groundwater well located on APN 019-640-021 and shared with CCL-864. Proposed activities are approved to include installation of a 10'x12' harvest storage shed, 10'x10' compost area, 10'x20' processing area on previously disturbed areas; also, an 8'x8' ag chemical shed and 5'x5' petroleum products storage shed both located on APN 019-640-021 and shared with CCL-864. There is a permitted onsite septic system located on APN 019-640-021 and shared with CCL-864 that services the project's wastewater needs. Power for the project is provided by generator less than 50hp. A more detailed project description can be found in the Appendix C Checklist.



Certified by the Board of Supervisors on December 21, 2020 (Resolution 2020-103). Pursuant to CEQA Guidelines (California Code of Regulations, Title 14) Section 15168, the impacts associated with the proposed project were studied, and mitigation measures concerning such impacts were developed, in the Cannabis Program EIR.
