Project Description: The proposed cultivation project described herein (Project) includes the cultivation of up to 10,000 square feet (SF) of mature canopy located in Trinity County on Assessor's Parcel Number (APN): 019-290-023-000. The applicant is seeking a Small Outdoor Cannabis Cultivation License from the County (CCL-873) and is also seeking an Adult Use Small Outdoor Cannabis Cultivation License from the Department of Cannabis Control (DCC). Cultivation activities are approved to include approx. 8,820sqft mature canopy in (99) existing and (81) proposed, total (180) 5'x5' boxes, 49sqft canopy each. Support infrastructure is approved to include a permitted onsite groundwater well, 30'x60' and 16'x60' drying structures, 16'x40' hoop house for immature canopy, 8'x8' ag chemical storage shed, 16'x24' processing, harvest storage shed; a 20'x20' composting area, a 2,000-gallon water storage tank and two (2) 275-gallon nutrient mixing tanks. Proposed activities are approved to include installation of additional (81) 5'x5' boxes as detailed above as well as repairing, replacing the existing boxes if appropriate. There is a permitted septic system onsite to serve the project's wastewater needs, and power for the project is provided by onsite solar systems. A more detailed project description can be found in the Appendix C Checklist.

Certified by the Board of Supervisors on December 21, 2020 (Resolution 2020-103). Pursuant to CEQA Guidelines (California Code of Regulations, Title 14) Section 15168, the impacts associated with the proposed project were studied, and mitigation measures concerning such impacts were developed, in the Cannabis Program EIR.
