Project Description: The proposed cultivation project described herein (Project) includes the cultivation of up to 10,000 square feet (SF) of mature canopy located in Trinity County on Assessor's Parcel Number (APN): 019-340-044-000. The applicant is seeking a Small Outdoor Cannabis Cultivation License from the County (CCL-867) and is also seeking an Adult-Use Small Outdoor Cannabis Cultivation License from the Department of Cannabis Control (DCC). Cultivation activities are approved to include approx. 9,984sqft of mature canopy in (156) 8'x8' canopy areas (110 existing and 46 proposed). Existing support infrastructure is approved to include a 10'x12' shed for agricultural chemical and pesticide storage; a permitted onsite groundwater well, a 20'x20' composting area and two (2) 2,500-gallon water storage tanks. Proposed activities are approved to include installation of two (2) 6' x 20' hoop houses for immature canopy, a 15' x 20' shed for processing and harvest storage, and a 12' x 15' shed for trimming/processing on previously disturbed areas. There is a permitted onsite septic system that services the project's wastewater needs. Power for the project is provided by solar systems and generators less than 50hp. A more detailed project description can be found in the Appendix C Checklist.

The County finds that the adoption of the proposed project falls within the Trinity County Cannabis Program Environmental Impact Report ("EIR") (SCH# 2018122049). Certified by the Board of Supervisors on December 21, 2020 (Resolution 2020-103). Pursuant to CEQA Guidelines (California Code of Regulations, Title 14) Section 15168, the impacts associated with the proposed project were studied, and mitigation measures concerning such impacts were developed, in the Cannabis Program EIR.
