The Project is expected to result in incidental take of tricolored blackbird (Agelaius tricolor), which is designated as a threatened species under the California Endangered Species Act (CESA). The ITP referenced above as issued by CDFW authorizes incidental take of species listed under CESA that may occur as a result of Project implementation.
