Project Description: The Ridge Walk North Living and Learning Neighborhood would redevelop an approximately 7.5-acre underutilized infill site adjacent to Geisel Library and east of Ridge Walk to provide approximately 2,444 new student beds (2,194 net new student beds), with a residential life program, plus 11 beds for professional staff. The project would include student dining, wellness programming, study lounges, housing and offices for residential life staff, and replacement space for housing operations administrative staff currently located at Eucalyptus Point. In addition to housing, the project would also include general assignment classrooms, a permanent home for Marshall College academic and administrative programs, a consolidated home for the Economics Department, expansion space for the School of Global Policy and Strategy, and public realm and site utility infrastructure improvements.

This Notice of Determination is to advise that the University of California Lead Agency has approved the above-described project on *March 16, 2023* and has made the following determinations:

1. The Project would not cause any significant environmental impacts nor an increase in the severity of significant impacts previously studied in the UC San Diego 2018 Long Range Development Plan (2018 LRDP) Environmental Impact Report (EIR).
2. Addendum #12 to the UC San Diego 2018 Long Range Development Plan (LRDP) Environmental Impact Report (EIR) was prepared for this project pursuant to the provisions of CEQA.
3. Relevant mitigation measures from the 2018 LRDP EIR were made a condition of the approval of the project; no new project-specific mitigation measures are required.
4. The implementation of applicable UC San Diego 2018 LRDP EIR mitigation measures will be monitored and reported pursuant to the 2018 LRDP EIR's Mitigation Monitoring and Reporting Program.
5. A Statement of Overriding Consideration was not adopted for this project.
6. Findings were made pursuant to the provisions of CEQA.
