The project proposes a Site Development Permit (SDP) for a public coastal accessway path located on a sensitive coastal bluff that would lead to the beach. The accessway is located within an existing coastal access easement at 7957 Princess Street. The 0.027-acre easement is adjacent to a single-family residence within the Residential Single Dwelling Unit (RS-1-7) Base Zone, Coastal (Appealable) Overlay Zone and Coastal First Public Roadway Overlay Zones and is designated Low-Density Residential (5-9 dwelling units/acre) and Dedicated Open Space Park within the La Jolla Community Plan Area. (LEGAL DESCRIPTION: A five-foot-wide strip over that portion of Lot 10 of Block 3 of Amalfi Subdivision, in the City of San Diego, County of San Diego, State of California, according to the Map thereof No. 959, filed in the Office of the County of San Diego Recorder of San Diego County, September 25, 1905)
