Project Title: McClure Bike Park VTP

Project Location: Mariposa County

Project Description: The California Department of Forestry and Fire Prevention (CAL FIRE) has prepared a Project-Specific Analysis (PSA) for the project as a later activity covered by the California Vegetation Treatment Project (CalVTP) Program Environmental Impact Report (EIR) for the McClure Bike Park VTP. The McClure Bike Park VTP entails implementation of vegetation treatments on up to 1,146 acres of land in Mariposa County, located within the Lake Don Pedro community. The proposed treatment types (fuel break and Wildland-Urban Interface Fuel Reduction) and treatment activities (manual treatments, mechanical treatments, prescribed (broadcast and pile) burning, prescribed herbivory, and herbicide application) are consistent with those evaluated in the CalVTP Program EIR. Maintenance treatments would involve the same vegetation treatment types and activities used in the initial treatments.

This is to advise that CAL FIRE (Lead Agency) has approved the above-described project on 6/9/2025 and has made the following determinations regarding the above-described project: Date

1. The project will have a significant effect on the environment.
2. A Program Environmental Impact Report (CalVTP Program EIR) was previously prepared (SCH# 2019012052) pursuant to the provisions of CEQA.
3. A Project Specific Analysis (PSA) was prepared for the McClure Bike Park VTP. This analysis determined the project is within the scope of the CalVTP Program EIR and consistent with CEQA Guidelines Section 15168(c)(2).
4. The CalVTP Program EIR sufficiently analyzes and addresses potential environmental impacts from the project, and the project will not trigger any of the criteria requiring additional CEQA review pursuant to CEQA Guidelines Section 15162. The project will not result in new significant impacts or a substantial increase in the severity of the significant environmental impacts identified in the CalVTP Program EIR.
4. Mitigation measures and standard project requirements from the CalVTP Program EIR were made a condition of the approval of the project; no new project specific mitigation measures are required.
5. The implementation of applicable CalVTP Program EIR mitigation measures and standard project requirements will be monitored and reported pursuant to the Mitigation Monitoring and Reporting Program that was adopted for this project.
6. The previous statement of overriding considerations in the CalVTP Program EIR was reaffirmed and adopted for this project by CAL FIRE.
7. Findings were made pursuant to the provisions of State CEQA Guidelines Section 15091.
